# CREATION OF SID No. 2

Mr. Greher reported that prior to creating the Alpine Mountain Ranch Metropolitan District Special Improvement District No. 2 ("SID No. 2), consents must be received from the certain property owners within the proposed boundaries of the SID No. 2. Two (2) consents are still outstanding, thus the District cannot yet create the SID No. 2. Therefore, the consideration and adoption of the Resolution creating the SID No. 2 was tabled until the next Board meeting.

## SID No. 1 BOND ISSUE

Upon discussion and motion duly made, seconded and unanimously carried, the Board adopted the Resolution authorizing issuance of the Special Improvement District No. 1 Special Assessment Revenue Refunding Bonds, Series 2021, in the principal amount not to exceed \$4,000,000.

## SID No. 2 Bond Issue

Upon discussion and motion duly made, seconded and unanimously carried, the Board adopted the Resolution authorizing issuance of the Special Improvement District No. 2 Special Assessment Revenue Bonds, Series 2021, in the maximum principal amount of \$4,175,000.

# COLLECTION OF SPECIAL ASSESSMENTS

Mr. Greher reviewed the Intergovernmental Agreement Regarding Collection of Special Assessments with the Routt County Treasurer for the collection of the special assessments to be collected to pay the Special Assessment Revenue Bonds. Upon discussion and motion duly made, seconded and unanimously carried, the Board approved the Intergovernmental Agreement and authorized the officers to execute.

# DTA COLLECTION AGREEMENT

Mr. Greher reviewed the draft Agreement for Consulting Services with DTA for collection and administrative services for the SID No. 1 and SID No. 2. Upon discussion and motion duly made, seconded and unanimously carried, the Board approved the Agreement substantially in the form presented, subject to review and approval of the final Agreement by Mr. Greher and the Chair, and authorized officers to execute.

Mr. Lucas and Ms. Knowles left the meeting. Mary Andre joined the meeting.

## <u>CAPITAL</u> IMPROVEMENTS

Chair Daly advised that Civil Design Consultants were requested to review the District's roads, water system and water treatment plant and submit recommendations to the Board regarding improvements to each. Ms. Andre summarized each of the options submitted to the Board. Upon lengthy discussion, the Board approved a combination of Options A and B for the designated road improvements, subject to the issuance of the Special Assessment Revenue Bonds.

## WATER ISSUES

Chair Daly reviewed the need and benefits of installing water meters. The Board discussed requiring the mandatory installation of a water meter beginning June 1, 2022, and assessing a penalty fee if such meters are not installed. The District would hire a plumber to be in charge of installing each of the meters. One of the primary benefits of a water meter is to better understand the water usage. Thereupon, a water rate structure would be able to be developed and become effective in 2023.

#### FINANCIAL ISSUES

Ms. Monroe submitted the current financials for review. Director Schlicht reported the need to replace the guard rails, which are deteriorating. The Board discussed pricing, which will take more

research. If the total cost will exceed the budgeted amount, Director Schlicht will bring the issue to the Board for approval.

There being no further business to come before the Board, the meeting was adjourned.

Infrastructure Acquisition and Reimbursement Agreement – Alpine Mountain Ranch Metropolitan District (the "Reimbursement Agreement") between Alpine Mountain Ranch Metropolitan District ("Metro District") and Alpine Mountain Ranch at Steamboat Springs, LLLP ("Developer")

#### Directors:

Developer is aware that the Metro District is planning to issue two series of special assessment revenue bonds, Special Improvement District No. 1 Special Assessment Revenue Refunding Bonds, Series 2021 and Special Improvement District No. 2 Special Assessment Revenue Bonds, Series 2021 (collectively, the "Bonds"), and that closing ("Closing") of the Bonds issuance is anticipated to occur on or before June 15, 2021. For avoidance of doubt, Closing shall be deemed to occur on the date the Bonds are exchanged for their purchase price.

This letter confirms Developer's agreement to forgive a portion of the accrued interest on the Infrastructure Acquisition and Reimbursement Agreement – Alpine Mountain Ranch Metropolitan District dated as of December 2, 2009 in the amount of \$1,494,000 ("Interest Forgiven"), which forgiveness is expressly conditioned upon the Closing of the Bonds. This agreement constitutes neither a novation nor an accord and satisfaction of the existing obligations of the Metro District to the Developer and, except as expressly provided herein relative to Interest Forgiven, the Reimbursement Agreement shall remain in full force and effect following the Closing, subject to annual appropriation by the Metro District's Board of Directors.
