WHEREAS, the Board of Directors of Alpine Mountain Ranch Metropolitan District adopted the budget and appropriated funds for the 2020 fiscal year as follows:

Capital Reserve Fund	\$ 0
Water Enterprise Fund	\$ 45.400
Debt Service Fund:	\$732,588
